Set up in 1997 by the Sanchal Foundation, the Hazards Centre is a professional support group and resource centre based in Delhi. We provide consultancy services to mass and community organizations on issues of development and environment.


Since 1997, the Centre has largely focused on people's issues, trying to help realize the rights of about 70% of Delhi's population, living on pavements, in slums, unauthorized colonies, resettlement colonies and urban villages. The work in Delhi provides the basis for interacting with other groups and sharing of experiences to develop a cogent perspective on the right to livelihood and shelter in cities. Currently, the Centre has been able to develop links with organizations in 18 other cities and towns.

The Centre also responds to rural organizations on issues of pollution, environment degradation, resource rights and livelihoods.

how we define hazards

We see the term "hazard" in an all-encompassing manner, as "anything that may threaten the survival of a group or community", and may thus mean to include lack of housing, opportunities for work, basic services, adequate information, harassment by the officials and the like.






Our Mandate








- If a community/ organization wants to know what are its basic rights and how to access these, wants to understand

RESEARCH

As citizens, we all seek answers to a range of questions on issues of planning and governance. What are the patterns of migration and settlement? What is the housing scenario for different sections? Can the present water supply meet the needs of a growing population? What is causing all the pollution in rivers? What has been done or not done to clean them? Is the cost associated with National prestige of building "world class" infrastructure actually worth it?? What has been the 'success' of the Metro in being a mass transport system? What does the Master Plan have to say about availability and distribution of basic services in the city? How can RTI be best used to improve administrative response? What are the 'development' plans in the coming years?

It is such and more concerns that we at Hazards Centre seek to provide answers to, using various techniques of research. We emphasize on participatory processes while gaining information from communities on their issues. Many of these researches are undertaken on requests from specific groups. These research data and the analytical conclusions to which they lead to, are documented in various simpler and easily comprehensible forms, so that they could serve as a base for further research and action.

One of the many strengths of the Centre is its extensive documentation and publication of its various research and analysis work, which essentially means recording of all such development processes that are increasingly marginalizing the poor, as also the strategies of resistance that are being formulated. TRAINING & WORKSHOPS

Being a support group, one of our most important roles is to organize workshops with communities and students which they request in order to provide them with diverse sets of information and skills to act upon their own problems. Special attention is paid to train community volunteers who are able to take up community issues, collect and collate information, and develop pro-people policy instruments, a process which thus becomes the basis of informed governance and decision-making.

Feedback from workshops and continuing demand from groups suggests that such information provision and training has significantly enhanced the capacity of community groups and of the student volunteers

- to gather data, analyse it, and use it for meeting their needs of daily survival
- to understand policies and react to legislative changes



Our Work

CAMPAIGNS

Every now and then a particular group or network builds up enough capacity to launch a public campaign for a change in policy or support for a specific cause. The Centre provides support whenever required for such campaigns in the form of drafting policy papers, making posters, or preparing information kits

- a. <u>Urban Right to Work Campaign:</u> A national campaign for legislation for protecting employment opportunities in urban areas
- d. People's Housing Policy: A draft policy providing details of how communities can build their own shelter with minimal but critical assistance from government
- c. Solid Waste Management: An approach to economic and ecological waste management by waste pickers
- d. Bus Rapid Transit System: Promotion of BRT as a cheap and systainable public transport
- e. <u>Climate Change</u>: A national campaign towards creating a new model of development in relation to adaptation, where one can learn from the lifestyle and knowledge of the lower classes
- f. Occupational Health & Safety: A campaign to promote safety at work place


